## UNDERTAKING

That the Management of the Institution undertake to comply with provisions of the clause 8(11) of the NCTE Regulations, 2014 which provide that whenever, there are changes in the norms and standards for a programme in teacher education, the institution shall comply with the requirement laid down in the revised norms and standards immediately. However, the revised land area related norms shall not be applicable to the existing institutions, but the required built up area shall have to be increased by them to conform to the revised norms and the intuitions not having land area as per the revised norms, shall not be allowed to expand by way of additional programs or additional intake.

- 4. That the management of the institution undertake to comply with the provisions of the clause \$(14) of the NCTE Regulation, 2014 which provide that the institution shall adhere to the mandatory disclosure in the prescribed format and display up-to date information on its Official website.
- 5. The institution undertake that it is fully aware to clause 7(3) of the NCTE regulations, 2014 which provide that Furnishing any wrong information or concealment of facts in the application, which may have baring on the decision making process or the decision pertaining to grant of recognition, shall result in refusal of recognition of the institution besides other legal action against its management order of refusal of recognition shall be passed after affording reasonable opportunity of hearing through a show cause notice to the institution.
